He started his career at the Internal Revenue Service serving as an Internal Revenue Agent, reviewer and classroom instructor and before commencing his own commercial law practice. Thereafter, he joined an accounting firm as the head of its newly created tax department and for the next 25 years served as Principal-In-Charge of the worldwide tax practice and as the firm's Vice President. During that period, he helped build a highly successful hedge fund and private equity fund practice, including a full-service fund administration business that was subsequently acquired by a public company.

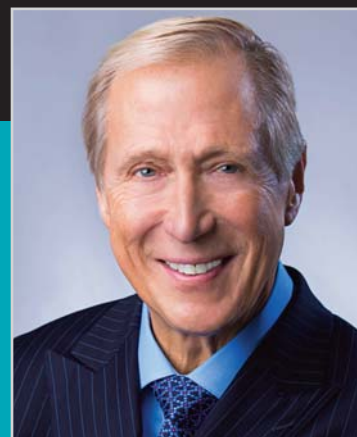
